
### कॉलेज के बारे में



### CHOICE -BASED CREDIT SYSTEM (CBCS)

The CBCS provides an opportunity for the students to choose courses from the prescribed courses comprising core, elective or skills-based courses. The courses can be evaluated following the grading system, which is considered to be better than the conventional marks system. Therefore, it is necessary to introduce a uniform grading system in the entire higher education in India. This will benefit the student to move across institutions within India, to begin with across countries. The uniform grading system will also enable potential employers to assess the performance of the candidates. In order to bring uniformity in the evaluation system and computation of the cumulative grade point average (CGPA) based on students' performance in examinations, the UGC has formulated the guidelines to be followed.

### **Outline of Choice Bases Credit System**

- **1. Discipline-Specific Core (DSC) Course:** A course, which should compulsory it be studied by a candidate as a core requirement is termed a Core course
- **2. Elective Course:** Generally a course which can be chosen from a pool of courses and which may be very specific or specialized or advanced or supportive to the discipline/subject of study or which provides an extended scope or which enables exposure to some other discipline/subject domain or nurtures the candidate's proficiency/skill is called an Elective Course.
- **2.1 Discipline-specific Elective (DSE) Course (2 each of regular courses):** Elective courses may be offered by the main discipline/subject to study is referred to as Discipline Specific Elective. The University/institute may also offer discipline-related Elective courses of an interdisciplinary nature (to be offered by the main discipline/Subject of study).
- **2.2 Dissertation/Project Work:** An elective course chosen of 6 credits, designed to acquire special/advanced knowledge, such as supplement study/support study to project work, and a candidate studies such a course on his own. Advisory support by a teacher/faculty member is called dissertation/project work. A project/Dissertation work may be given instead of a discipline-specific paper.
- **2.3 Generic Elective Course (GEC):** An elective course chosen generally from an unrelated discipline/subject, to seek exposure to other subjects/disciplines is called a Generic Elective Course.
- **P.S.:** A core course offered in a discipline/subject may be treated as an elective by another discipline/subject and vice versa and such electives may also be referred to as Generic Electives.
- 3. Ability Enhancement Course (AEC)/Competency Improvement Courses/Skill Development Courses Foundation Course: The Ability Enhancement (AE) Courses may be of two kinds AE Compulsory Course (AECC) and AE Elective Course (AEEC). "AECC" courses are courses based on the content that leads to knowledge enhancement. They [(I) Environment Science, (ii) English/MIL

Communication] are mandatory for all disciplines. AEEC courses are value-based and/or skill-based and are aimed at providing hands-on training, competencies, skills, etc.

- 3.1 Ability Enhancement Compulsory Course (AECC): Environmental Science, English Communication
- **3.2 Skill Enhancement Course (SEC) (Minimum 4):** These courses may be chosen from a pool of Courses designed to provide value-based and/or skill-based instruction.

### **ELIGIBILITY:**

#### 5.1 BA/B.Com. 1st Year:

**I.** A pass in the Senior Secondary (10+2) examination (Academic Stream) conducted by the HP Board of School Education or an examination accepted as equivalent thereto by the various bodies of the H.P. University.

### II. Minimum percentage for admission:

- (a) B.A. 1<sup>st</sup> Year: 33% (however a student can opt for mathematics in B.A. 1<sup>st</sup> Year only if he/she has studied it in 10+2 and has obtained 45% marks in mathematics or 45% marks in aggregate).
- **(b) B.Com. 1<sup>st</sup> Year**: 45% (however it is 40% for those who have passed 10+2 from the commerce stream and for the girls candidates, it is 33%).

A relaxation of 5% marks for SC and ST students for admission to the commerce facility will be given.

### 5.2 BA/B.Com. 1<sup>st</sup> /2<sup>nd</sup> /3<sup>rd</sup> Year:

Admission will be based on a roll-on system. A student who has been expelled or rusticated from any college will not be eligible for admission to any course without the prior approval and permission of the Vice Chancellor. While determining percentage of marks for eligibility, rounding up of fraction of 0.5% marks or above to the next full unit is permissible. The above condition of minimum percentage is subject to Sardar Patel University, Mandi amendments from time to time. If a student does not produce the actual marks sheets from the Board/University in respect of 10+2 where the result is shown in grades of the equivalent exam, standards, etc., the minimum percentage of marks for each grade/standard will be taken into consideration while determining his/her eligibility for the purpose of admission.

A candidate from the National School of Open Learning will be eligible for admission to B.A. 1<sup>st</sup> Year only if he/she has passed all five subjects including English (as per Ordinance of SPU Mandi.

For fresh admission to the first year of the Course, the **maximum age limit is 23 years** on the first of July of the year concerned. In the case of **SC/ST** candidates a **relaxation of three years** is allowed. The Vice-Chancellor, SPU Mandi, may be recorded in writing to give relaxation in age up to a maximum of six months to other candidates also. All such cases may be provisionally granted age relaxation of up to six months by the Principal of the college and a consolidated list of all such cases will be sent for the approval of the Vice Chancellor by 31st October of every academic Year. A candidate seeking admission to

B.A./B.Com-1styear must have studied Mathematics and English at the 10<sup>th</sup> level. The maximum age limit for admission to B.A./B.Com-1syear classes for women students has been raised to 25 years by the SPU Mandi.

Note: 1. 10+2 students placed under compartment in the 10+2 class are not eligible for admission in the first year of three-year degree programmes in Arts/Commerce.

2. NEP 2020 will be implemented as per the directions of SPU, Mandi/HP Govt.

Board of School Education or from any other School located within territorial jurisdiction of Himachal Pradesh or a bonafide of Himachal Pradesh. For reservation the following roster will be followed.

### 7.0 For the Degree:

- a) The candidate shall have to undergo the prescribed course of study for a period not less than three academic years (and not more than five academic years) to pass the examination prescribed and fulfill such conditions as have been prescribed therewith.
- b) For the degree, the students will have to accumulate a minimum of 132 successful credit hours of course work. Not more than three attempts will be allowed to pass a course.

### **Continuous Comprehensive Assessment (CCA)**

**CCA Scheme:** For students enrolled for the Academic session 2019-20 onwards, CCA will account for 30% of total marks i.e. 100, which a student will get in a course. The breakup of 30%, i.e. 30 marks is given below.

It is approved that a student will have to pass both the components i.e. CCA and ESE separately to become eligible to be declared successful for the course.

**Mode of conducting Minor Test** (15 Marks): Minor test will be conducted after the completion of 48 teaching days (8 weeks).

### (A) Three Types of questions will be set in Minor Test:

- 1. 5 MCQ (Choice: 1 out of 4) and True/False type of questions of one mark each = 5 marks
- 2. 2 questions of Short answer type of 2.5 marks each = 5 marks
- 3. 1 question of about 500 words = 5 marks

#### **Total of minor test =15 Marks**

### (B) Distribution of marks for evaluation of Tutorial/Home Assignment etc.:

- 1. 5 marks are assigned for the quality of contents and structure of the assignment.
- 2. 5 marks are assigned for the clarity of language of the script (Hindi/English) and its presentation in the class room.

**Total Marks: 30** 

### (C) Classroom attendance = 5 marks

Each student will have to attend a minimum of 75% lecture tutorials and practical. A student having less than 75% attendance will not be allowed to appear in the Annual Examinations / End-Sem. Examinations (ESE).

#### **Grievance and Rederessal Mechanism:**

- 1. The Students will have the right to make an appeal against the component of evaluation. Such appeal has to be made to the Principal of the College on a prescribed form and should clearly state in writing the reason/s for the complaint/appeal.
- 2. The appeal will be placed before the Grievance Redressal Committee (GRC) chaired by the college Principal, comprising:
- a) For cases pertaining to the core and electives subjects.

The Head of the Department, course teacher and a senior teacher of the department. The committee will consider the case and may given a personal hearing to the appellant before deciding the case. The decision of the committee will be final.

As per the strict instruction of the Govt. of H.P. based on the ruling of Hon'ble Supreme Court, it is mandatory for the candidate to be accompanied by one of his parents at the time of admission.

**Note:** For more detail of Choice Based Credit System Please visit of SPU Mandi website. Fresh instruction/regulation if any received from SPU Mandi and Government of Himachal Pradesh will be implemented in the college.

### 13.0 Guidelines for Admission:

i) A student seeking admission to the college for the first time must produce a Character Certificate (not more than six month old) from the Head of the Institution last attended. In case of private candidate/or candidate having a gap after qualifying examination, must have to produce the same from any gazetted officer/competent authority. A college student seeking admission to the next higher class should not have anything reported against his/her character/behaviour in the college and in the examination hall during the previous academic year.

- ii) Admission to the college is a matter of discretion and not a matter of right. THE DECISION OF THE PRINCIPAL WILL BE FINAL IN THE MATTER OF ADMISSION. HE/SHE HAS THE POWER OF REFUSE/TERMINATE ANY ADMISSION ON DISCIPLINARY GROUNDS OR WITHOUT ASSIGNING ANY REASON.
- iii) Submission of false information of any kind for the purpose of admission is serious offence. Any such act will be viewed seriously with penal proceedings and admission will be cancelled instantaneously. Any candidate seeking Registration/Admission by furnishing wrong information or by suppressing information in respect of address, age, subjects studied and percentage of marks, etc. will be punished with disciplinary and legal action.
- iv) All admissions are provisional unless confirmed/approved by the university and the college authority will assume no responsibility in case the University for Any reasons whatsoever does not approve the admission of a student.

- 7. Bonafide Himachali (for H.P. Girls)
- 8. Aadhaar Card (Copy)/Enrolment No.
- 9. An attested copy of the previous result should be submitted in the college office within 10 days after declaration of result by SPU Mandi.
- v) Private students seeking admission in the college for the first time or after a gap of one year or more should submit recent character certificate (not more than six months old) issued by a M.L.A./ Gazetted Officer/Sub-Divisional Magistrate/Tehsildar/Naib-Tehsildar.
- vi) Certificate of SC/ST from Magistrate (Class-1) for those seeking relaxation or benefits thereof.
- vii) Affidavit giving reason/s for gap years if there is break in continuity after last exam passed.
- viii) Certificate of Bonafide Himachali (For girls students who belong to H.P.)

### Note: Only girl students who are Bonafide Himachali are eligible for exemption of tuition fee.

- ix) The candidates who have passed the previous examination from another Board must submit the following:
- a) Eligibility Certificate from the H.P. Board/University equivalence of the courses studied by them for the purpose of admission.
- b) Original Migration Certificate from Board/University where they passed the previous examination.
- c) Detailed marks sheet of exam passed.
- d) Character certificate (in original) from the Head of the institution last attended.

- (Admission without these documents will be purely provisional and at the candidate's own risk and responsibility)
- e) All original certificates must be produced at the time of admission/interview.

#### 13.2 Re-Admission:

- i) The name of student who are **absent for more than ten days continuously** in a class without proper permission will be struck off from the college roll. However, the Principal in his discretion may re-admit such students after the recommendation of the concerned teacher on payment of the admission fee of Rs. 100/- for first time and Rs. 200/- for second time along with a fine (to be decided by the Principal). No further readmission after second time is allowed.
- ii) The student whose name is struck off from the college rolls due to shortage of attendance shall have to seek re-admission within four days, failing which he/she will not be eligible for re-admission. He/she will have to bring his/her parent/guardian, who will assume responsibility for the students' regularity in classes in the remaining period of the academic session. However, re-admission may be granted at the risk and responsibility of the concerned student as he/she will have to complete the required number of lectures as per SPU Mandi norms.

### 13.3 Change of subjects:

Change of subjects is permissible only in the first Year within 7 days of the commencement of teaching.

### 13.4 A student can change his/her subject only once:

- i) As such he/she is advised to be very careful in exercising this option.
- ii) A student will be allowed to change the subject only if he/she has the required percentage of marks for admission to that subject/faculty.

### 13.5 Procedure for change of subject:

- i) A student who wants to change the subject/faculty offered must apply in duplicate to the Principal after getting No Objection Certificate from the concerned teachers/HOD.
- ii) The college reserves the right to refuse admission to such courses/combinations for which human or material resources are not available at the time of admission or there is apprehension of non-availability of such resources.

### **13.6 Migration Rules:**

- i) Migration from other colleges to Govt. Degree College, Lad Bharol and vice-versa is governed by SPU, Mandi rules.
- ii) No migration certificate can be issued unless the student is registered with the university.
- iii) The migrating student must submit the following documents/information:

- a) Lecture Attendance statement (of all subjects offered) duly countersigned by the Principal
- b) Statement of marks obtained in Term Exams in previous college.
- c) Character Certificate from the Principal of the college last attended.
- iv) After migration has been sanctioned and notified by the university, the student must join the second college within the time period stipulated by the university.
- v) The college first joined is entitled to the tuition fee for the month in which the university sanctions the migration. The second college is not entitled to the tuition fee for that month or part thereof. Different rules are applicable in case of migration to/from private colleges.
- vi) The admission of student migrating from other university or from an affiliated college or an institution in the same course (including the directorate of correspondence courses) shall be governed by the regulations framed by the E.C. of SPU Mandi time to time.
- vii) The admission of students migrating from another university shall be treated as provisional and shall be confirmed when he/she produces the migration certificate issued by the university and a certificate of good conduct issued by the Head of the Institution last attended.
- viii) A student disqualified by another university will not be given admission during the period of disqualification.

### 13.7 Specific Rules of Admission & Migration:

i) Inter-university migration rule for seeking admission to Part II under plus 3 System (ord.3.11) is as follows:

If the Principal of the college where the student seeks/wishes to seek admission, is satisfied with the recommendations of the teacher/s in the concerned subject that the student has studied courses/syllabus of first year/ syllabus of first/second semesters in the previous recognized university, then the principal shall recommend the migration case properly to the university for approval well in time, i.e. in the beginning of the session in a consolidated form and not in piecemeal. If the Principal is not satisfied with the recommendations of the teacher/s in the concerned subject that the courses/syllabus of this university, then either such admission should be refunded by the Principal in the beginning of the session or he/she shall ask the student to study an additional paper on the subject and then this fact be brought to the notice of the university well in time but such a student will have pass the 1<sup>st</sup> year exam of this university simultaneously along with other yearly papers. However, all such Inter university migration, are to be finally approved by H.P.U./S.P.U.

- ii) In case of Inter-college migration of the candidate, the Head of the institution to which the student wants to migrate must also agree before the university allows the migration.
- iii) While attesting the inter-college migration form of the candidate, the Head of the institution shall clearly state, whether the student was detained in the class in which he/she has been studying and whether any disciplinary action of a serious nature such as rustication, expulsion etc. was ever taken against him/her.
- iv) The student must join the new college with requisite certificates within fifteen days of the date of issue of the migration certificate, failing which the sanction of migration case will lapse. To get it revived, the entire procedure, including the deposit of prescribed fee, will have to be undergone a fresh.

- v) The migration fee, once deposited, shall not be refunded in any case.
- vi) If a student, after submitting the application for migration wishes not to migrate before the migration has been sanctioned by the university he/she may be allowed to do so, but the migration has been sanction, he/she shall apply through the Principal of the institution where he/she continues to be, along with the migration certificate issued to him/her, for its cancellation, which may be allowed by the Registrar/Controller of Exams.

### 14.0 Applying for Leave:

- i) Students applying for leave should get the leave application duly recommended by all the concerned teachers.
- ii) The concerned teachers must ensure that the student is regular in the class before recommending such applications.
- iii) Leave beyond 3 days will be sanctioned by the Principal in special circumstances.
- iv) The students will be marked absent during the leave period and the period will be considered absence while calculating the lectures attended by him/her and determining his/her eligibility to appear in the university examination. However his/her name will not be struck off the rolls in case the leave is properly sanctioned and hence no fine shall be levied.

### **15.0 TUTORIAL GROUPS:**

After the completion of admission process, students will be classified randomly into various tutorial groups. With the help of tutor the students can set and achieve their goals, further tutor also encourages the students to be disciplined and to help them to stay on track.

### **16.0 Scholarships and Fee Concessions:**

- i) A number of scholarships and fee concessions are available to the eligible and deserving students. Information regarding the dates, eligibility conditions and procedure for applying these scholarship/concessions etc. will be notified on the college notice board from time to time. For additional information contact the convener of the committee/college office. However only the pass students of previous class are eligible to apply for any scholarship.
- ii) The students may contact convener of scholarship committee for online filling up of scholarship forms. The hard copy of the same should be duly attested/verified by the competent authority and should be accompanied by the relevant certificates of educational qualification/income/caste/tribe/domicile/Aadhaar card/copy of bank account /photograph etc.

The scholarships/concessions available are:

- i) Post Matriculation Scholarship for SC/ST Students: For students belonging to S.C./S.T. category whose parents annual income does not exceed Rs. 2.5 lacs.
- ii) Post-Matric Scholarship for OBC Students: Students who belong to O.B.C category are entitled to his scholarship, if the annual income of their parents is up to Rs. 1.5 lacs.
- iii) Dr. Ambedkar Post-Matric Scholarship for Economically Backward classes: Under this scheme, all students belonging to general category (other than SC, ST and OBC) whose total income from all sources in case of the employed candidates and in case of unemployed candidates, his/her parents/guardians income shall not exceed Rs.1 lakh per annum, are eligible for full scholarship.

- iv) Post-Matric Scholarship Scheme to students belonging to Minority community: For this Scholarship annual income of the parents/ guardians of the beneficiary should not exceed Rs. 2.0 lakh from all sources and student should not have less than 50% marks in the previous final examinations.
- v) Indira Gandhi Utkrisht Chhattervrity Yojna for Post +2 students: The scholarship is awarded to the top ten male students from the merit list of 10+2 Arts/Science/Commerce supplied by the H.P. Board of School Education Dharamshala, and to the top ten (male and female) from the merit list of B.A./B.Sc./B.Com, supplied by HPU Shimla/ SPU Mandi, provided they join any academic/professional stream. Rate of scholarship will be @ Rs. 10,000 per annum.
- vi) Maharishi Balmiki Chhattervrity Yojna for girls Students: This scholarship is meant for girls who belong the Balmiki family and whose parents are engaged in unclean occupation. Under this scheme, the government provides a scholarship of Rs. 9000/- per annum as financial assistance.
- vii) IRDP/BPL Scholarship Scheme: The students who belong to IRDP/BPL families are eligible for this scholarship. A sum of Rs. 1200/per annum is provided as financial assistance.

### viii) Scholarship for Children of Army Personal Martyred/Disabled during War:

Eligible students may apply to the Dy. Director, Sainik Welfare Board of the respected District. Rate of scholarship provided under this scheme is Rs. 12000 per annum.

- **ix)** Half fee concession: (a) one of two or more real bothers studying in the college will be eligible for 50% concession in tuition fee. The brother studying in the lowest class will be entitled to this concession. This concession is also available in case of sister/sisters who do not belong to Himachal Pradesh and as such are not entitled to exemption of tuition fee.
- b) Fee concession is also available for physically challenged students and Himachal Bonafide female students as per H.P. norms.

**Note:** The scholarship and fee concessions mentioned above are subject of the latest rules/regulations/guidelines of HP. Govt./Centre Govt./ SPU Mandi/HPU Shimla may change accordingly.

### 17.0 Discipline and conduct:

The principal and the members of staff have the power to take disciplinary action against students indulging in acts of indiscipline, which may lead to imposing fine, suspension, rustication or expulsion of the guilty student(s).

- i) The students are expected to confirm to the rules and regulations, which are notified from time to time in addition to those contained in this prospectus.
- ii) The students should come to the college and leave it according to the Time-Table.
- iii) Roaming about in the campus, corridors and outside classrooms during vacant periods and causing disturbance to teaching work in this manner is highly undesirable and will be considered as an act of indiscipline.
- iv) Damage of any kind to college property including defacement of walls, damage to furniture etc. are acts of indiscipline.
- v) No student will put up notices on the college notice board without proper authorization by the college authorities. Notices without the signatures of the Principal or a member of the teaching staff will not be valid.

vi) Use/ possession of narcotics and tobacco products etc. strictly prohibited in the campus. Strict action will be taken against the offenders according to law.

### 18.0 Menace of Ragging:

- i) Ragging includes any type of physical or mental torture inflicted by any individual or group, either by words or by conduct, which creates an apprehension in the mind of the person that he/she cannot pursue his/her studies free from any mental disturbance or torture created thereby. Any person who aids or abets such an action shall also be guilty of ragging.
- ii) Ragging in and around the college campus or on roads is strictly prohibited. If any student is found indulging in ragging directly or indirectly, the college authorities shall be obliged under Rule 22, 17(a), (b), (c) of H.P. University to expel the guilty student(s) from the college and report the matter to the police as ragging amounts to a criminal offence as per a judgment of the Hon'ble Supreme Court of India.
- iii) The Hon'ble Supreme Court as well as the Hon'ble High Court has also directed the university to frame rules with regard to complete ban on ragging. Consequently, SPU Mandi /Himachal Pradesh University has framed the rules vide Notification No. 1-14/HPU/DSW/08-/360 dated 10th July, 2008 and as per these rules, any student found involved in ragging will be punished appropriately which may include:
- a) Expulsion from the university/college.
- b) Suspension from the classes.
- c) Fine with a public apology.
- d) Withholding scholarships or other benefits.
- e) Debarring from the representation in events.
- f) Suspension or expulsion from hostel or mess.
- g) Legal proceedings under criminal law shall be initiated.
- iv) All students admitted to the college jointly with their parents shall be deemed to have given the following undertaking:

I have gone through the given rules and regulations regarding ragging and discipline of the university/college and I hereby solemnly affirm that I will not indulge in any act of ragging/indiscipline that f l am found guilty of such offences as are covered under these rules, I will have no claim against the order of rustication/expulsion from the college.

### 19.0 College Identity Card:

Once the admission of a student to the college is confirmed, he/she should collect his/her identity card from the college office/the librarian well in time. It will be the total responsibility of the student to get his/her identity card duly signed by the tutor, librarian and the Principal/his nominate authority within 15 days of the start of regular classes. No student without identity card will be allowed to enter the college campus.

- i) Each student must carry his/her identity card with him/her while in the college campus, which must be produced whenever it is demanded by any member of the teaching staff. Failure to do so should entail strict disciplinary action.
- ii) The identity card is an important document. In case the identity card is lost, the same should be reported immediately to the college authorities along with the police report of having lost the card. A fine

of Rs. 30.00 will be charged for issuing a duplicate identity card along with Rs.10.00 as the cost of the card.

### 20.0 Library

The college is trying to enrich the library facilities with the addition of the text books and general books every year. Besides, a number of magazines and newspapers have been subscribed for the benefit of students and members of staff. Along with this, the college library has better seating arrangements for the students as well as staff members. All admitted students shall have to pay library security amount of Rs. 100/- each at the time of first entry to the college and same is refundable up to 31st March of the year succeeding his/her passing out leaving the college, whichever is the case. No security will be refunded after this date.

### 21.0 NSSINCC/Rover & Ranger:

Half Unit of NSS has been established in the college, NCC and Rovers and Rangers will be established in near future.

### 22.0 Sports and Go-Curricular Activities:

The college organizes sports & Co-curricular activities to widen the mental horizon of the students and to provide opportunities for the development or their potential to the fullest through different clubs and societies like the Cultural Society, Eco-Club and Red Ribbon club/ Youth Red Cross/ Energy Club/ Road Safety Club. These clubs/societies organize talks, debates, surveys, quiz contests and other competitions in the related fields. Besides preparing the students to participate in inter-college competitions like the SPU Mandi Youth Festivals, SPU Mandi sports competition etc. Students are also encouraged to celebrate occasions of national importance and cultural significance.

### 23.0 College Students Central Association:

As per the norms of the HPU/SPU the College Students Central Association is constituted every year by way of elections/nomination to the posts of four office bearers (i.e. President, Vice President, Secretary and Joint-Secretary) and representatives from different fields in the month of August as per the university schedule. The schedule and the eligibility criteria for the elections/nominations are notified well in time as per the directions of the SPU Mandi authorities.

### 24.0 Fee, Funds and Fines:

- i) 1st installment: Annual charges and fees at the time of admission
- ii) 2<sup>nd</sup> installment: In the month of November/December

College fees and other charges are to be paid on the dates according to the schedule for each class as notified by the college office. A fine of Rs 1/-per day will be charged from the students who violate the notified schedule for the payment of fees. However the name of a student will be struck off from the college rolls if the dues are not paid within 10 days of the deadline. If a student fails to pay his/her fee by the end of the month in which fees and fine are charged his/her name will be struck off from the college rolls. Re-admission fee of Rs. 100/- along with specific fine will depend on the discretion of the Principal. A student leaving College will have to pay fees and funds for the entire month in which he/she leaves the

college. He/she will have to obtain clearance from the college office, library and other concerned departments to the effect that he/she has paid all college dues.

### Ragging-A Punishable Offence

If an individual or a group of students gives mental or physical torture to a new student because of which he/she is afraid/unable to pursue his/her studies in an academic atmosphere, it shall be treated as ragging. Any student, found involved in ragging, will be punished appropriately and the punishment may include:

- 1. Expulsion from the College/University
- 2. Suspension from the classes
- 3. Fine with a public apology
- 4. Withholding Scholarships or other benefits
- 5. Ban to represent the college in various sports/cultural events.

Legal proceedings under criminal law shall be initiated. Any person, who is found to contravene the provisions of section (I) of Himachal Pradesh Education Institution (Prohibition of Ragging) ordinance, 2009 shall on conviction, be punished with imprisonment for a term which may extend up to three years or fine which may extend up to fifty thousand rupees or both.
